The quoted rate should be for one laptop per day and will be valid for a minimum duration of 1 year.
- 5. The office of CEE need not necessarily accept the lowest quote, if the same is not as per the specifications and the decision in this regard shall be final. This office reserves the right to ask for the Bank guarantee, for the proper execution of the order, in case desired.
- 6. The office of CEE reserves the right to negotiate the cost with L1 vendor to discover better price.
- 7. The office of CEE reserves the right to reject any/all quote, without assigning any reasons for cancellation.
- 8. The selected agency shall agree with the undersigned specifying the terms and conditions.
- 9. Maximum delivery period will be 7 days from the date of receipt of supply order.
- 10. The last date for EOI submission is 27-04-2024 at 4.00pm.
- 11. Priority will be given to high-end models with greater processing power over lowerend models with fewer cores and processing capabilities.
